## **TRUSTEE REPORT, MARCH 2019**

## 2019-2020 Budget Process - 8 Areas of Focus

The Finance, Budget and Enrolment Committee (FBEC) have been meeting to develop a draft Operating Budget for 2019-2020. You can find all the information on the Budget at the <u>Board's</u> Website.

Based on the Multi-Year Strategic Plan's (MYSP) goals and related action plans, staff have identified and proposed eight key areas as proposed strategic drivers for the 2019-2020 budget. They are broad areas of focus which will be used as a first step in guiding these important budget conversations. The proposed strategic drivers are:

Professional Development; Staff Allocation; Early Years; Student Success;

Different Approaches to Serve our Students; Parent Engagement and Student Voice;

Modernization and Accessibility; Indigenous Education

On March 27, my Scarborough colleagues and I will be holding a Joint Budget Ward Forum from 7 – 9 pm at 140 Borough Drive. Staff will present the information about the budget process and draft strategic drivers. An online survey will be developed to capture feedback from the community.

#### **Cancellation of funding for Priority School Initiatives**

The Ministry of Education has cancelled funding for The Priority Schools Initiative (PSI) aimed at making 77 TDSB school spaces more accessible by providing not-for-profit organizations and community groups, free after-hours access to school facilities in communities that need it most.

In Ward 20, the following schools were included: **Chester Le Jr PS, Fairglen Jr PS, Highland Heights Jr PS and Pauline Johnson Jr PS**.

Arts Intersection Bus Tour May 30, 2019, 9 am – 2 pm (more info to follow) Given the importance of this grant to the city's priority neighbourhoods, the Board recently voted to proceed with no cost permits for schools serving these communities without a subsidy from the province to fulfill our commitments for this schoolyear.

In addition, the Ministry has made no decision as to whether funding will continue for the **Summer Focus on Youth Program**. Last year, funding from this program allowed the TDSB to hire and train more than 600 youth to work alongside community partners – from all across the city – to help serve over 11,000 young people. This program has documented evidence of helping children with more access to learning, employment and leadership opportunities. If the funding is cancelled, the Summer Focus on Youth Program at our schools/sites will be seriously affected:

Chair Pilkey has written to all Toronto MPPs to express the Board's concerns for the reduction in provincial funding for the Community Use of Schools - Priority Schools Initiative EPO, as well as the cancellations and reductions of other grants that help our most in-need communities and youth. She has also appeared before the Ontario Legislature's Standing Committee on Finance and Economic Affairs and presented a <u>submission</u> focusing on:

- Concerns with the early signs of the provincial government's fiscal restraint plan.
- Advocacy for Education Development Charges (EDCs)
- Stable and predictable funding to tackle TDSB's renewal backlog which sits at about \$3.9
  billion as of January 2019, and continues to rise

# **Autism Funding Announcement**

As you may know, the Government of Ontario recently <u>announced changes</u> to how they support families of children with autism.

The announcement has shifted significant funding from school-aged children to pre-school aged children in order to prioritize early clinical intervention for students aged 4 or younger. The reality is the funding provided for school-aged children has been reduced dramatically, likely resulting in many families no longer being able to afford clinical services.

We anticipate the result of this being more school-aged children transitioning from being in a clinical setting for part of the day or week to being in school with us full time. Consequently, we anticipate the potential impact on our resources regarding access to behavioural expertise, staffing, and to critical capacity building to support the effective use of Applied Behaviour Analysis (ABA) strategies by our front line staff throughout the system. There is the very likelihood that we will experience additional demands on these support services while the TDSB has already spent close to \$39M more in special education funding than the government provides as you can read in Financial Facts.



We will continue to advocate for an increase to special education funding so that we are able to provide the support all students need to thrive.
